#### 6. PRINCIPAL REPORT

See the October 2021 report presented by Ms. Boris. She spoke about their fund raiser, the reada-thon. She also said that they won't be holding the Spring Musical this year because if they had to cancel it due to COVID, they would have too much invested into it. She said that they would be bringing back many of the smaller activities this school year.

## 7. TEACHER REPORT

Ms. Roth, 3rd grade teacher, presented the teacher report. She said that the 2nd grade has been working on adjective café and the 3rd grade has been working on science – biomes around the world. She also spoke about multiplication and the health series on body systems. She also spoke about a student that had been really struggling and they decided, along with the parent, to move him down a grade and that he is now happy and really thriving. Dr. Simpson wished to thank the teachers in behalf of the board and parents. He said the COVID year has been a bad year for the kids.

### 8. PTO REPORT

Ms. Boris spoke on behalf of Mr. Smith, who was sorry he couldn't be there. She said that the PTO was planning their fundraiser. She said that they had a uniform sale that very evening and she talked about family night. She also talked about what a dedicated and friendly person Mr. Smith is and that he has been active with Oakland for many years and that everyone loved him.

## 9. FBR REPORT
